- **Subtheme 1:** On-Train Restrooms - Participants reported dissatisfaction with the cleanliness of on-train restrooms, emphasizing the need for standardized cleaning protocols.
- **Subtheme 2:** Availability of “women-only” facilities—Participants reported that there were no “women-only” facilities available on the train.

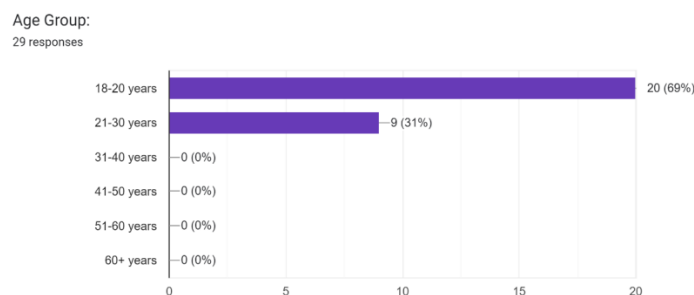
### ***1.3 Comfort Considerations:***

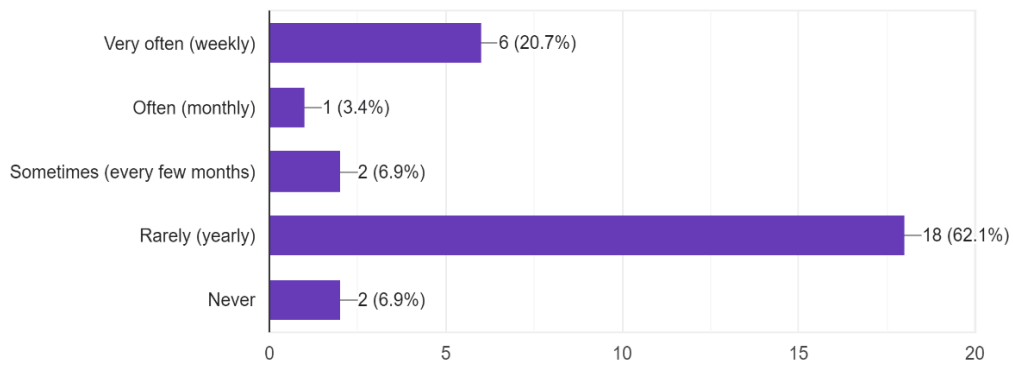

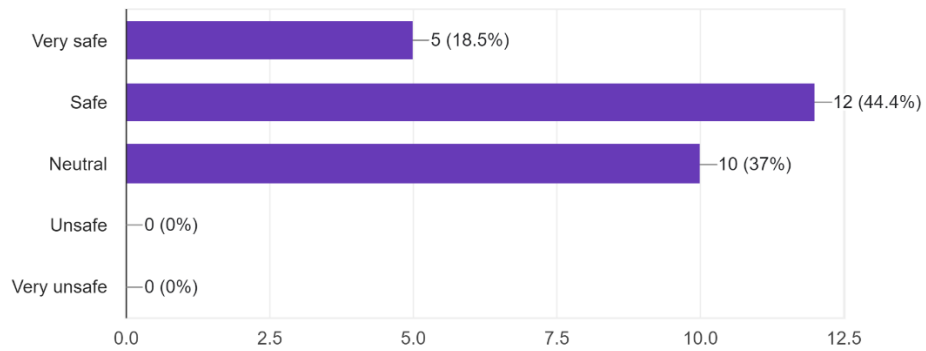
### Frequency of train travel:

29 responses



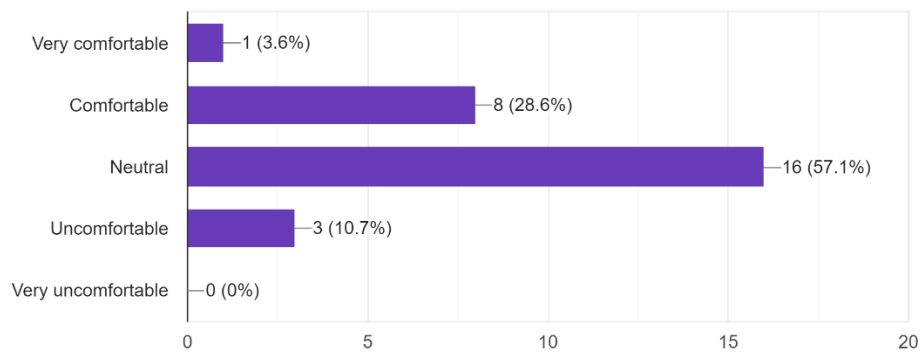
### Feeling of safety during travel:

27 responses



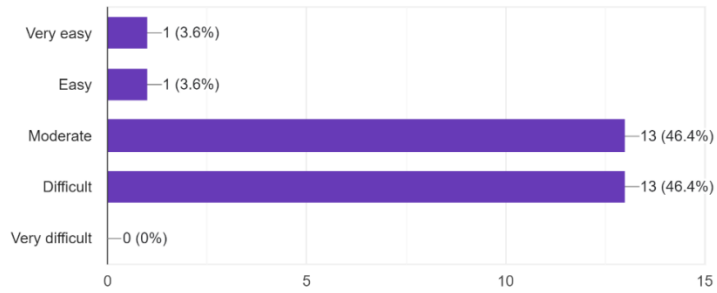
### Comfort level in sleeping arrangements:

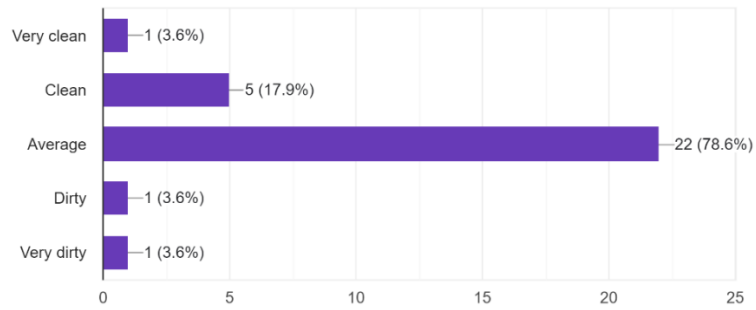

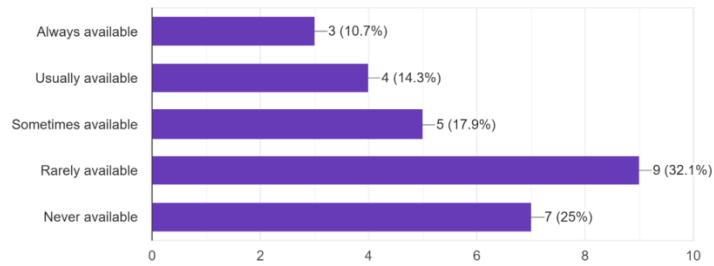
Ease of access to sanitary facilities:

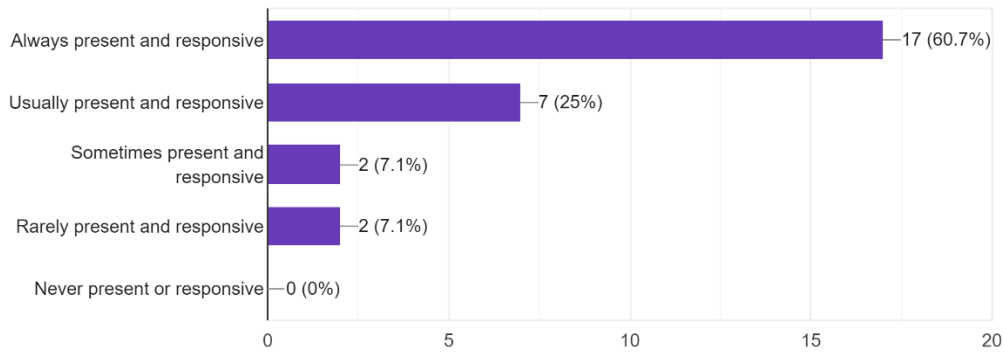
Availability and accessibility of 'women only' facilities:

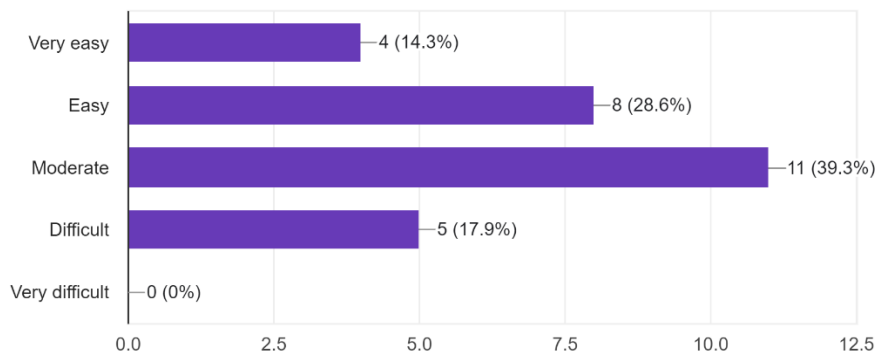
### Presence and responsiveness of security personnel:

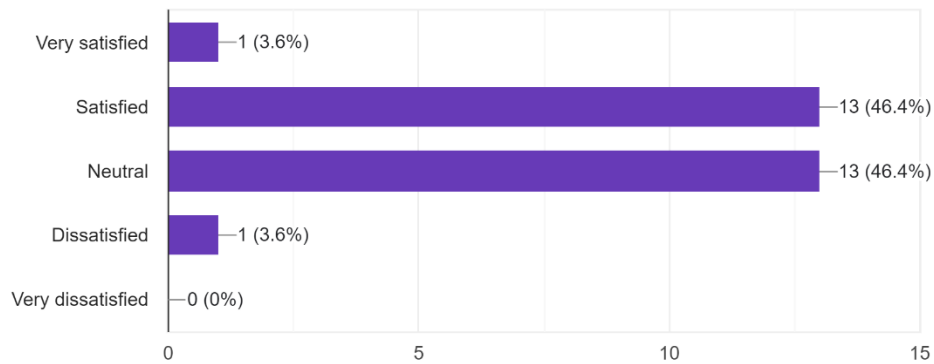
### Ease of accessing emergency assistance:
